Logista Confirmed for the Ninth Year in the “Leadership” Category of the CDP Index

Logista has demonstrated continuous progress and a solid track record in its sustainability strategy

Logista, the leading distributor of products and services to points of sale in Europe, reaffirms its best practices in sustainability policies. For the ninth consecutive year, the company has been included in the Leadership category of the prestigious CDP index (formerly Carbon Disclosure Project), a recognition that confirms Logista’s commitment to environmental management.

CDP is an international non-profit organization that provides businesses, local authorities, governments, and investors with a global system for measuring and reporting environmental performance.

Over the past nine years, Logista has demonstrated continuous progress in its strategy to minimize environmental impact. This has been achieved through the implementation of innovative measures to reduce emissions and by improving resource efficiency. In the 2024 edition of the CDP index, the company received a score of A-, placing it in the highest rating tier.

The CDP Score Report 2024, which evaluated over 22,000 companies, confirms that Logista’s sustainability actions and its long-term commitment to transparent and responsible resource management have been deemed excellent.

Logista is the only European logistics operator that has remained in this category for nine consecutive years, demonstrating a strong ability to integrate environmental sustainability policies into its business model. Its approach goes beyond regulatory compliance, encompassing numerous initiatives that involve the entire value chain.

This ongoing commitment has also been validated by additional recognitions. In January 2024, *Sustainalytics* positively certified the company’s sustainability strategy as part of its corporate social responsibility and governance assessment. Additionally, the MSCI (Morgan Stanley Capital International) index recently assigned Logista an A rating.

Iñigo Meirás, CEO of Logista, emphasized: *“This achievement not only reflects our commitment to sustainability but also demonstrates our ability to maintain continuous progress in implementing responsible practices.”*

Logista has also integrated all its activities in Italy into a strategy aimed at reducing environmental impact. This includes the use of renewable energy to power its operational sites and a plan focused on increasing self-produced energy.

Among its reverse logistics initiatives, the Logista Green Box project promotes the reuse of delivery cardboard boxes up to four to five times before recycling them. Meanwhile, the RECYCLE-CIG project ensures the proper collection and disposal of used electronic cigarettes.

Logista is one of Europe's largest logistics operators, specializing in the distribution of products and services to proximity channels. It regularly serves nearly 200,000 points of sale across Spain, France, Italy, Portugal, the Netherlands, Belgium, and Poland, offering the fastest and most efficient market access for a wide range of products, including convenience items, pharmaceuticals, electronic recharges, books, publications, tobacco, and lotteries. It also operates Spain's largest transport network, certified for food safety.

Logista relies on a team of highly qualified professionals, with over 8,000 direct employees and numerous partners, including Nacex affiliates, Logista Parcel delegates, drivers, and more. Employees and collaborators work together to provide clients with the most efficient and tailored service possible.

In Italy, Logista has built one of the largest logistics and commercial proximity networks and is recognized as an efficient and neutral partner. With over 90 warehouses, it supplies 60,000 points of sale, ensuring an annual tax revenue of approximately €15 billion for the state.

Commitment to Sustainability

For eight consecutive years, Logista has maintained its position as a leader in the CDP, which recognizes global leaders in the fight against climate change. It is the only European logistics company to have been included in this category during this period.

Additionally, in May 2024, Sustainalytics—one of the world's leading ESG (Environmental, Social, and Governance) risk rating agencies—awarded Logista an ESG risk rating of 16.5 points, classifying it as Low Risk for financial impacts due to ESG factors. Logista was also recognized as "Industry TOP RATED 2024", ranking among the top 50 companies in the transportation sector worldwide.

Thanks to its strong corporate social responsibility efforts, Logista secured an MSCI rating of "A" in 2024, on a scale from AAA to CCC. The company also participated in the S&P Corporate Sustainability Assessment (CSA) and was recognized by the Financial Times in February 2024 as a "Diversity Leader." In April 2024, Ecovadis awarded Logista a Bronze Medal for its sustainability performance.

Logista is also part of the FTSE4Good IBEX index, which includes companies demonstrating strong environmental, social, and governance (ESG) practices, as well as the Ibex Gender Equality index. In 2022, Logista joined the Ibex 35.
